5. CHAIR'S REPORT

The Vice Chair thanked the College for its ongoing support to ensure the success of the Foundation. While the Foundation Board sadly farewelled long serving member Mr David Matters in 2023, we were extremely pleased to welcome current parent Mrs Kate Clarke and old scholar Dr Emily Aldridge to the Board. In their short tenure they have eagerly contributed and she thanked them for their enthusiasm, expertise and willingness to serve.

The 2023 annual black-tie dinner A Glitter Ball was a great success and raised \$42,273.00, all of which will go directly to help the students of Trinity to excel.

The Board was especially pleased that the Foundation was able to support the College with a donation of \$150,000 to the Marnkutyi Parirna Performing Arts Theatre that was officially opened in

October 2023. The Foundation was able to match funds donated by our community to this building project and 136 plaques have been placed on chairs to acknowledge these donors.

Additionally, the Foundation Board endorsed and implemented a new Spending Policy that will ensure funds donated are directed as expediently as possible for the purposes they were collected. The policy will be reviewed by the Board in 2026.

6. FINANCE REPORT

R Johnstone reported that in 2023, a number of investments were realised. The Foundation Board is very thankful to the College for providing all necessary resources at no charge for banking, reconciliation, auditing and full management of Foundation funds.

While sound financial management is key to the success of the Foundation, rather than focus exclusively on the accumulation of wealth, the Foundation Board seeks to disturb funds as expediently as possible for the purpose they have been raised. The subsidy of the annual Canberra Trip for all Year 7 students is a good example of this practice in action.

QUESTION FROM THE FLOOR: R Thorne asked if 'we index these levels?' R Johnstone responded 'no, but perhaps we should.'

R Johnstone thanked the College and its Finance team for managing the daily financial obligation of the Foundation as well all members of the Foundation Board Finance Sub-Committee for their input over the past 12 months.
